**RESERVATIONS AND PAYMENTS:** Reservation Requests are subject to acceptance by AnywhereAdventures and are only confirmed upon receipt of a deposit payment of \$750 per person. Final Payment of the full balance is due by 30 October 2011.

**CANCELLATIONS AND REFUNDS:** All requests for cancellations must be made in writing and are effective as of the date received at the AnywhereAdventures office.

If a trip is canceled more than 65 days prior to departure, a full refund of all payments received will be made, less a service fee of \$100 per person. If a trip is canceled less than 65 days but more than 45 days prior to departure, a refund of all payments will be made, less a cancellation fee of \$500 per person. If a trip is canceled less than 45 days but more than 15 days prior to departure, a refund of all payments will be made, less a cancellation fee of \$1800 per person. No refunds will be made for cancellations less than 14 days prior to departure, for no-shows, and for unused trip services.
